SCHEDULE FOR PENDING TEXT AMENDMENTS

The pending text amendment schedule has been updated since it was last presented to the Council on March 22, 2010 (updated text amendment summary attachment). Two text amendments have been added to the schedule:

- Shelter special standards and guidelines; and
- Planned Development Housing minimum land area requirement in residential districts.

BACKGROUND ON TWO TEXT AMENDMENTS

<u>Shelter Special Standards and Guidelines</u>: During the review of the Interfaith Council's proposed Community House in late 2009, there was public discussion of the definition and occupancy limits for shelters. On <u>January 11, 2010</u>, the Council enacted Land Use Management Ordinance Text Amendments regarding the definition and permit requirements for shelters. Following enactment of the text amendment, the Council referred a petition to staff and the Planning Board to initiate a process for the Planning Board to recommend special standards or guidelines for homeless shelter to the Council.

Planned Development-Housing minimum land area requirement in residential districts: This text amendment was considered by the Council on March 17, 2008 and pertains to Planned Developments – Housing, which involve review and approval of multi-family residential developments by the Town Council as Special Use Permits. The proposed amendment would reduce the minimum land area requirement for multi-family developments from 5 acres to 1 acre for sites in residential conditional use zoning districts. During the March 17, 2008 meeting the Council determined to defer consideration of this item to a future date pending receipt of information regarding long term water supply. In order to track the progress of this item, it has been incorporated into the attached schedule.
